PICKLEBALL TEST PROPOSAL BY THE GENESEE FOUNDATION

- A) Mr. Wadja, President of the Foundation, presented the current status of pickleball in the foundation. He spoke about the following pickleball options:
 - 1. Agree to GF proposed 2-3 mo test of pickleball at Solitude, beginning April 1. GWSD monitors disruptions from parking, restroom requests, noise, etc. GWSD can then report the recommendation to yes or no on moving pickleball permanently.
 - 2. Agree to GF proposed test with confirmation of Peter Wadja's offer of temporary portaporty installation and with qualifiers of option 1.
 - 3. Deny request pending winterization of restroom for year round use, or agree to test upon completion of that project, then proceed with qualifiers of option 1.
 - 4. Deny the request outright on the basis that the board believes pickleball is not likely compatible with GWSD operations.

RESERVOIR COMPLETION UPDATES

- A) Mr. Anderson reviewed the most recent updates of the reservoir including the effort of staff to complete some electrical conduit work at the sewer treatment plant during 2 night shifts. By staff doing this project in-house, it saved the District about \$45,000.
- B) We also got verbal approval that once the EAP (Emergency Action Plan) is complete, we can begin to fill the reservoir. Mr. Brownell and the Engineering Firm are working on that currently. We also do not want to start filling until the fence is completed.
